## <u>ORDER</u>

WHEREAS, in exercise of powers in exercise of powers conferred under Section 144 of Cr. PC hereby order that curfew was imposed in the District till further orders for the containment and prevention of the spread of COVID19.

WHEREAS, to ensure essential goods and services and bona-fide movement of people for the same, the <u>Restricted Movement and Curfew Passes</u> were issued for purposes such as:

- 1. Electronic and print media.
- 2. Supply and distribution of milk, food, grocery, vegetables and fruits to retailers/ and through hawkers, home delivery agents.
- 3. Provision of dry and green fodder for animals and veterinary services.
- 4. Uninterrupted supply of LPG, Petrol Pumps.
- 5. Supply and opening of chemist shops and essential industry for health services such as pharmaceuticals.
- 6. Supply of telecom and internet services.
- 7. Manufacturing, packaging and transport of all these essential goods.

THEREFORE, in view of extension of curfew, these passes issued earlier <u>shall now</u> <u>remain valid till the end of curfew/ lockdown.</u>

Further, it is reiterated that vide orders of Department of Home Affairs, Government of Punjab:

- a. Workers and vehicles engaged for the above-mentioned purposes shall be allowed to move freely.
- b. Passes issued for essential supplies would be valid across the State.
- c. Passes issued for essential supplies by other states/ districts shall also be valid in this District.
