Subject: Revamp of Health Infrastructure for fighting against COVID-19 in the State of Punjab.

There is an urgent need to revamp health infrastructure in line with requirement of fighting COVID-19 in the State of Punjab. There is a need to:-

- (i) Create adequate Isolation facilities along with commensurate Civil Infrastructure;
 - (ii) Repair & up gradation of Public Health facilities,
 - (iii) Repair & renovation of Electrical fittings etc.
- so to match the standard requirements for fighting this crisis.

2. Accordingly, an Inter-departmental Committee of officers is hereby constituted as under which shall, by obtaining field reports, recommend revamp of health infrastructure as elaborated in Para-I, in **State Medical Colleges & Hospitals, District Hospitals & Sub-divisional Hospitals:-**

- (1) Sh. Arun Kumar, Chief Engineer, Public Works (B&R)- Member/convenor
- (2) Sh. Vijay Kumar Chopra, Chief Engineer, Electrical-Member.
- (3) Sh. S.K. Jain, Chief Engineer, Water Supply & Sanitation- Member.
- (4) Dr. Parvinder Sidhu, Director, NHM, Punjab- Member.

3. The above committee shall submit its report giving out clearly the detailed requirements along with requisite estimated funds to Principal Secretary, Public Works (B&R) at the earliest, and in any case latest by 11.04.2020.


